# SECOND AMENDED AND REINSTATED ARTICLES OF INCORPORATION

OF

PEREZ ACRES HOMEOWNERS ASSOCIATION, INC. REGISTRATION BRANCH OCTOBER 24, 2024

We, the undersigned natural persons, of the age of twenty-one years or more, acting as Incorporators of a corporation pursuant to 18 GUAM CODE ANNOTATED Section 10101, do adopt the following Articles of Incorporation:

#### ARTICLE ONE NAME

The name of this corporation is "PEREZ ACRES HOMEOWNERS ASSOCIATION, INC.

#### ARTICLE TWO DURATION

The period of duration for this corporation shall be perpetual or until such time as the Board of Directors shall adopt a resolution recommending that the corporation be dissolved.

#### ARTICLE THREE PURPOSES

The purposes for which the corporation is organized are to promote social welfare within the meaning of Section 501(c)(4) of the Internal Revenue Code, including but not limited to:

- (a) Exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in that certain Declaration of Covenants, Conditions and Restrictions (the "Declaration") recorded in the office of the Recorder, Department of Land Management, Government of Guam as Instrument No. 240609 on October 8, 1974, and as the same may be amended from time to time as therein provided, the Declaration being incorporated herein as if set forth at length;
- (b) Fix, levy, collect and enforce payment by an lawful means, all charges or assessments pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Corporation, including all licenses, taxes or governmental charges levied or imposed against the property of the Corporation;
- (c) Acquire (by gift, purchase or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, hold, improve, build upon, operate, maintain, convey, sell, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Corporation;

#### ARTICLES OF INCORPORATION OF PEREZ ACRES HOMEOWNERS, INC

- (d) Borrow money, and with the amount of two-thirds (2/3) of each class of members, mortgage, pledge, deed in trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- (e) Dedicate, sell or transfer all or any part of the Common Area or of the Association's surface rights in the ponding area, to any public agency, authority, or utility for such purposes and subject to such conditions as my be agreed to by the members. No such dedication or transfer shall be effective unless an instrument has been signed by two-thirds (2/3) of each class of members, agreeing to such dedication, sale or transfer;
- (f) Participate in mergers and consolidations with other nonprofit corporations organized for the same purposes or annex additional residential property and Common Area, provided that any such merger, consolidation or annexation shall have the assent of two-thirds (2/3) of each class of members;
- (g) Have and to exercise any and all powers, rights and privileges which a corporation organized under the General Corporation Law of Guam by law may now or hereafter have or exercise.

This corporation is not organized for profit, and no part of the net earnings of this corporation shall inure to the benefit of any member of the Board of Directors or any other individual except that this corporation may make payments of reasonable compensation for services rendered.

The corporation shall not participate or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office to an extent that would disqualify it from tax exemption under Section 501(c)(4) of the Internal Revenue Code. The corporation shall never be operated for the primary purpose of carrying on a trade or business for profit.

Notwithstanding any provision of these Articles of Incorporation, this corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States internal revenue law).

#### ARTICLE FOUR MEMBERS

Every person or entity who is a record owner of a fee or undivided fee interest in any Lot which is subject under the Declaration to assessment by the Corporation, including contract sellers, shall be a member of the Association. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. Membership shall be appurtenant to and may not be separated from ownership of any Lot which is subject to assessment by the Corporation.

#### ARTICLE FIVE VOTING RIGHTS

Members shall be entitled to one vote for each Lot owned. When more than one person holds an interest in any Lot, all such persons shall be members. The vote for such Lot shall be exercised as they among themselves determine, but in no event shall more than one vote be cast with respect to any Lot.

#### ARTICLE SIX REGISTERED OFFICE AND AGENT

The address of the initial registered office of this corporation is 701 South Marine Corps Drive, suite 101, Tamuning, GU 96913, and the name of its initial registered agent at such address is Christopher Felix, residing in Guam.

## ARTICLE SEVEN AMENDMENTS TO ARTICLES OF INCORPORATION

This corporation reserves the right to amend or repeal, by affirmative vote of a majority of the members of its Board of Directors, any of the provisions contained in these Articles of Incorporation.

#### ARTICLE EIGHT FUNDS AND ASSETS

This corporation shall use its funds only to accomplish the purposes stated in this Articles of Incorporation. This corporation shall not have authority to issue capital stock. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to, and only to, one or more charitable organizations.

#### ARTICLE NINE DIRECTORS

The manner in which Directors shall be elected or appointed shall be provided in the Bylaws of the corporation. The names and addresses of the persons who are to serve as initial Directors until their successors are elected and qualified are:
